The Boone County Commission met in REGULAR SESSION on Tuesday, February 19, 2019. Those present for the meeting were Commission President Eddie Hendricks, Commissioner Craig Bratcher and Commissioner Brett Kuhn. Staff present was Pam White, Administrator, and Lee Ann Dale, Assistant Administrator.

This meeting was recorded on CD 517A and 517B. Commissioner Hendricks ask if there were any objections to the agenda and called the meeting to order at 3:30 p.m.

At Track 1 on CD, Commissioner Bratcher made a motion to approve the Exonerations as prepared and presented by the Assessor's Office, seconded by Commissioner Kuhn, motion passed.

At Track 1 on CD, Commissioner Kuhn made a motion to approve the Minutes from the February 5, 2019, Regular Meeting, seconded by Commissioner Bratcher, motion passed.

Track 2 on CD, Commissioner Bratcher made a motion to approve the County Clerk's Appointments and Finals as presented by the County Clerk's Office, seconded by Commissioner Kuhn, motion passed.

At Track 3 on CD, Larry Green, Prosecuting Attorney Investigator, submitted the Regional Jail bill in the amount of \$80,384.50, for the month of January, 2019.

At Track 4 on CD, Michelle Akers, Southwestern Regional Day Report Center Director, spoke to the Commission regarding the FY 2020 Memorandum of Understanding.

At Track 5 on CD, Terry Martin, RIC Project Director and Toby Waller, Boone County Public Service District, updated the Commission on various water projects.

At Track 33 on CD, Commissioner Bratcher made a motion to approve the request of Randall White, Sheriff, to transfer Evan Gibson from the Home Confinement Officer to Deputy in Law Enforcement, effective February 20, 2019, with an annual salary of \$33,240.00, including benefits, and to attend the West Virginia State Police Academy, seconded by Commissioner Kuhn, motion passed.

At Track 40 on CD, Commissioner Bratcher made a motion to approve to request a time extension from the Land and Water Conservation Fund Grant, for the Waterways Amphitheater stage and restrooms, and further authorizes the Commission President, Eddie Hendricks, to sign on its behalf, as requested by Kris Mitchell, Boone County Development Authority Director, seconded by Commissioner Kuhn, motion passed.

At Track 41 on CD, Commissioner Bratcher made a motion to approve to correct the total number of board members of the Boone County Development Authority; the initial Board of Directors shall consist of thirteen (13) members, five (5) members of which shall be appointed for a term of one year, four (4) members of which shall be appointed for a term of two years, and four (4) members of which shall be appointed for a term of three years, as requested by Kris Mitchell, Boone County Development Authority Director, seconded by Commissioner Kuhn, motion passed.

At Track 42 on CD, Commissioner Bratcher made a motion to approve the request of Boone County School Superintendent, Jeff Huffman, to hold a Special Election, on November 2, 2019, to renew the School Levy, seconded by Commissioner Kuhn, motion passed.

At Track 43 on CD, Greg Lay, Emergency Management Director and Michael Mayhorn, IT/Emergency Operations Supervisor, spoke to the Commission regarding upgrading the E-911 CAD, mapping and phone system.

At Track 64 on CD, Commissioner Bratcher made a motion to approve to update the E-911 CAD/Mapping and phone system, with Zuercher Technologies, seconded by Commissioner Kuhn, motion passed.
