The Boone County Commission met in REGULAR SESSION on Tuesday, March 5, 2019. Those present for the meeting were Commission President Eddie Hendricks, Commissioner Craig Bratcher and Commissioner Brett Kuhn. Staff present was Pam White, Administrator, and Lee Ann Dale, Assistant Administrator.

This meeting was recorded on CD 520. Commissioner Hendricks ask if there were any objections to the agenda and called the meeting to order at 1:30 p.m.

At Track 1 on CD, Commissioner Bratcher made a motion to approve the Exonerations as prepared and presented by the Assessor's Office, seconded by Commissioner Kuhn, motion passed.

At Track 43 on CD, Commissioner Bratcher made a motion to approve for the WV Coal Festival to use the parking lot across from the Courthouse and the Maintenance parking lot on the week of June 18 through June 22, 2019, and permission for the Maintenance Department to move bleachers and the Maintenance Electrician services, as requested by Joy Underwood, President, seconded by Commissioner Kuhn, motion passed.

At Track 45 on CD, Terry Martin, Project Director of the Intergovernmental Regional Council updated the Commission on the Morrisvale Cameo Waterline Project and the Rock Creek Industrial Park Infrastructure Development.
