The Boone County Commission met in REGULAR SESSION on Tuesday, May 21, 2019.

Those present for the meeting were Commission President Eddie Hendricks and Commissioner

Craig Bratcher. Staff present was Pam White, Administrator, and Lee Ann Dale, Assistant

Administrator. Commissioner Brett Kuhn was absent.

This meeting was recorded on CD 528. Commission President Eddie Hendricks called the meeting to order at 3:30 p.m. and ask if there were any objections to the agenda.

At Track 1 on CD, Commissioner Bratcher made a motion to approve the Exonerations as prepared and presented by the Assessor's Office, seconded by Commissioner Hendricks, motion passed.

At Track 1 on CD, Commissioner Bratcher made a motion to approve the Minutes from the May 7, 2019, Regular Meeting, seconded by Commissioner Hendricks, motion passed.

At Track 1 on CD, Commissioner Bratcher made a motion to approve the County Clerk's Appointments and Finals as presented by the County Clerk's Office, seconded by Commissioner Hendricks, motion passed.

At Track 2 on CD, Michael Mayhorn, E-911 Operations Supervisor updated the Commission on the CAD/Phone/Mapper installations.
