The Boone County Commission met in REGULAR SESSION on Tuesday, September 3, 2019. Those present for the meeting were Commission President Eddie Hendricks, Commissioner Craig Bratcher and Commissioner Brett Kuhn. Staff present was Pam White, Administrator, and Lee Ann Dale, Assistant Administrator.

This meeting was recorded on CD 540. Commission President Eddie Hendricks called the meeting to order at 1:30 p.m.

At Track 1 on CD, Commissioner Bratcher made a motion to approve the Exonerations as prepared and presented by the Assessor's Office, seconded by Commissioner Kuhn, motion passed.

At Track 1 on CD, Commissioner Kuhn made a motion to approve the Minutes from the August 27, 2019, Regular Meeting, seconded by Commissioner Bratcher, motion passed.

At Track 1 on CD, Commissioner Bratcher made a motion to approve the County Clerk's Appointments and Finals as presented by the County Clerk's Office, seconded by Commissioner Kuhn, motion passed.

At Track 2 on CD, Harvey Ferrell and Randy Lipford, Boone Raleigh Public Service District Board Members updated the Commission.

At Track 7 on CD, Commissioner Kuhn made a motion to go into Executive Session for a financial matter, as requested by Harvey Ferrell and Randy Lipford, Boone Raleigh Public Service District Board Members, seconded by Commissioner Bratcher, motion passed.

At Track 7 on CD, the Boone County Commission was back in regular session.

At Track 8 on CD, the Estate of Georgia Annie Older Hearing was held.

At Track 11 on CD, Commissioner Kuhn made a motion to appoint Joseph Stewart as the Administrator of the Estate of Georgia Annie Older, seconded by Commissioner Bratcher, motion passed.

At Track 12 on CD, the Estate of Kathy Ruth Fenwick Hearing was held.

At Track 14 on CD, Commissioner Bratcher made a motion to remove Sandra Cook, as Executrix of the Estate of Kathy Ruth Fenwick, and appointed the Boone County Sheriff as the Administrator, seconded by Commissioner Kuhn, motion passed.

At Track 16 on CD, Commissioner Bratcher made a motion to approve for Kris Mitchell to attend the 2019 WVEDC Annual Conference held at the Marriott in Morgantown, on September 22 through September 24, 2019, including registration and lodging, seconded by Commissioner Kuhn, motion passed.

At Track 17 on CD, Commissioner Kuhn made a motion to approve to change the status of Arch Griffith to Emergency Management Operations Supervisor, replacing Michael Mayhorn, with an annual salary of \$38,000.00, effective September 4, 2019, as requested by Greg Lay, Emergency Management Director, seconded by Commissioner Bratcher, motion passed.

At Track 18 on CD, Commissioner Kuhn made a motion to grant authority to the Administrator, Pam White and County Maintenance Director, Kerry Dickens, to explore the disposition of county properties, seconded by Commissioner Bratcher, motion passed.

At Track 19 on CD, Commissioner Bratcher made a motion to approve to cut the contribution to the Health Department for the Fiscal Year 2019-2020, in the amount of \$59,639.00, but will give the contribution of paid utilities and free rent, seconded by Commissioner Kuhn, motion passed.

At Track 20 on CD, Commissioner Kuhn made a motion to approve to cut the contribution to the Boone County Community Organization for the Fiscal Year 2019-2020, in the amount of \$33,866.00, seconded by Commissioner Bratcher, motion passed.

At Track 21 on CD, Commissioner Bratcher made a motion to approve to cut the contribution to the Parks & Recreation for the Fiscal Year 2019-2020, in the amount of \$288,000.00, seconded by Commissioner Kuhn, motion passed.

At Track 29 on CD, Sue Ann Zickefoose, Circuit Clerk, spoke to the Commission regarding her budget cuts.

At Track 35 on CD, Roger Toney, County Clerk, spoke to the Commission regarding his budget cuts.

At Track 41 on CD, Randall White, Sheriff, spoke to the Commission regarding his budget cuts to the Law Enforcement and Sheriff's Tax Office.

At Track 43 on CD, Scotty Cook, Assessor, spoke to the Commission regarding his budget cuts.
