The Boone County Commission met in REGULAR SESSION on Tuesday, January 19, 2021. Those present for the meeting were Commission President, Craig Bratcher, Commissioner Brett Kuhn and Commissioner Jacob Messer. Staff present were Pam White, Administrator, and Lee Ann Dale, Assistant Administrator.

This meeting was recorded on CD 590A and 590B. Commission President, Craig Bratcher called the meeting to order at 3:30 p.m.
