This meeting was recorded on CD 596. Commission President, Craig Bratcher called the meeting to order at 3:00 p.m.

At Track 1 on CD, Commissioner Messer made a motion to approve the Exonerations as prepared and presented by the Assessor's Office, seconded by Commissioner Kuhn, motion passed.

At Track 1 on CD, Commissioner Kuhn made a motion to approve the Minutes from the February 23, 2021, Regular Meeting, seconded by Commissioner Messer, motion passed.
