The Boone County Commission met in REGULAR SESSION on Tuesday, June 29, 2021. Those present for the meeting were Commission President, Craig Bratcher, Commissioner Brett Kuhn and Commissioner Jacob Messer. Staff present were Pam White, Administrator, and Lee Ann Dale, Assistant Administrator.

This meeting was recorded on CD 607 and 607A. Commission President, Craig Bratcher called the meeting to order at 3:30 p.m.

At Track 1 on CD, Commissioner Kuhn made a motion to approve the Exonerations as prepared and presented by the Assessor's Office, seconded by Commissioner Messer, motion passed.

At Track 1 on CD, Commissioner Messer made a motion to approve the Minutes from the June 15, 2021, Regular Meeting, seconded by Commissioner Kuhn, motion passed.

At Track 2 on CD, Commissioner Kuhn made a motion to approve the County Clerk's Appointments and Finals as presented by the County Clerk's Office, seconded by Commissioner Messer, motion passed.

At Track 2 on CD, the Commission honored Jenna Butcher, Scott High School sophomore, who won the Class A/AA State Championship in girls tennis.

At Track 4 on CD, the Commission honored Shealyn Stone, a student at Madison Middle School, whose entry was recognized as an honorable mention recipient in the County Commissioners Association of West Virginia's essay contest, and was presented with an award from the association.

At Track 12 on CD, Terry Martin, Regional Intergovernmental Council Project Coordinator, updated the commission on the Right Fork water project and about the various sewer projects under design. Also, he spoke on behalf of the Boone County PSD regarding a potential water project.

At Track 61 on CD, Commissioner Messer made a motion to approve the request of Harvey Ferrell, Mayor of the Town of Sylvester, to provide up to \$30,000.00, from the reallocated coal fund and allow the Maintenance Department, to build a restroom at the Sylvester Pavilion Park, seconded by Commissioner Kuhn, motion passed.

At Track 67 on CD, Commissioner Kuhn made a motion to approve for the Maintenance Department to remove old carpet from the Prosecuting Attorney's Office and refinish and repair the original hardwood flooring, seconded by Commissioner Messer, motion passed.

At Track 70 on CD, Commissioner Messer made a motion to accept the resignation of Jerry Marcum, Deputy Assessor, effective July 1, 2021, and grant his request for payment of his unused annual leave hours, in the amount of \$3,023.03, for 251.5 hours, as requested by Scotty Cook, Assessor, seconded by Commissioner Kuhn, motion passed.

At Track 72 on CD, Commissioner Kuhn made to approve the request of Scotty Cook, Assessor, to hire Nikki Sampson, at an annual salary of \$25,008.00, to replace Brooke Asbury, effective June 30, 2021, pending pre-employment drug screen, seconded by Commissioner Messer, motion passed.
