WBVFD is currently looking to update our current supply of pagers and batteries for our crucial rescue tools that are life saving pieces of equipment. Pagers are crucial to provide fast and dependable emergency notifications for emergency 911 responses for our response area, as well as other areas of the county. Our current pagers are old and most are not working or are unreliable, thus causing a risk to the citizens of our response area. We also currently have members on WBVFD that do not have a pager and have to rely on an app to notify them when there is an emergency. These new batteries will update our current old batteries to a more dependable power source. These rescue tools include the Hurst Jaws of Life (x2), Hurst Spreader (x2), Hurst Cutter (x2), and the Hurst Ram (x2). These mentioned tools are used to extricate trapped victims in MVCs and other types of situations. These tools are very vital to the WBVFD and the community that we serve.

2. Please describe goals and expected outcomes of your proposal.

The goal of these new pagers is to ultimately provide a quick and reliable way to provide enhanced notifications to our members when an emergency in our community appears. These new pagers have the capability to use both UHF and VHF frequencies to provide notification of an emergency response to our members, so they can quickly respond to the emergency of the citizens of our immediate and second due response areas.

The goal of the new eDRAULIC batteries is to provide efficient and dependable extrication services at any given time. These tools are essentially wireless as we can removed them from our trucks, and take them over hillsides if needed to where ever the victim may be and be able to quickly and safely remove them from any MVC that they me be entrapped in our objects they may be stuck under.

If the Boone County Commission was to award the WBVFD with this funding, the pagers and batteries for the rescue tools would be purchased as soon as the funding was provided to the VFD.

The total proposed budget that we, The WBVFD is requesting is \$19,156.50 USD.

Pagers - \$12,082.50 eDRAULIC Batteries- \$7,074.00

WBVFD would be partnering with two outside dealers to purchase these items, Discount Communications and Electronics, located in Alum Creek, WV. DCE is the local dealer that we use to purchase radios and pagers. The second dealer would be Interstate Rescue, Located in Winchester, VA.

Once the grant has been awarded to WBVFD the pagers and new batteries for the rescue tools would be purchased and as soon as these would be delivered and programmed. Implementation of these to our members would be immediate to provide better notifications of emergencies to our members and the batteries will be installed and immediately put to use.

The WBVFD also has a LUCAS device that aids during the cardiac arrest calls, as this device does mechanical chest compressions for the first responders on scene so they can better treat the patient.

The WBVFD is also proud to have been recognized along with several other departments in the county as to how much water we are safely able to move with Vacuum tankers at the scenes of fires. This is a big help, due to several areas in the county not having adequate fire hydrants and or tankers to immediately service their area. With these tankers, we are able to pump water out of creeks, rivers, or any type of water source.
