The purpose of this application is to secure funding to assist us in purchasing a new concession sales trailer for our organization. The Danville Area Lions Club uses profit from concession sales to provide vision health care and prescription glasses to the underserved residents of Boone County. These residents are typically working people who do not have vision insurance and make too much income to qualify for public assistance. We also provide two scholarships to qualified seniors of Boone County Schools per year, and support various youth leagues, organizations, and benevolence causes with donations and sponsorships. Our concession trailer needs repairs that are not economically feasible to perform. We need to replace the concession trailer so we can continue to raise money for our benevolence and community projects.

The Danville Area Lions club has proudly served the residents of Boone County for 32 years and have done so to this point by being self-funded. We have hot dog and barbecue concession sales throughout the year to raise money to support our outreach programs. Our primary mission is the gift of sight. We supply vision health and prescription glasses to the underserved residents of Boone County. These concession sales typically are held at the Boone County Fair, the WV Coal Festival, Rev UP Madison Cruise In, etc. The Covid 19 Pandemic cancelled fairs and festivals across the nation. Boone County was no exception. As a result of these Covid cancellations, the Danville Area Lions Club was unable to operate at our usual venues. These lost revenue sales have impacted our ability to fund a replacement concession trailer while providing the community with services at the pre Covid levels.

The cost to replace the concession trailer is \$43,458.94 We have raised money from concession sales this spring and private donations, but we are short \$31,809 at this point. We are requesting

\$10,000 or any amount the commission feels is appropriate. We have raised \$7900 from donations and \$800 from concession profit dedicated to the replacement trailer fund. A portion of the profit goes to the general operating fund to use for benevolence, vision health mission, and scholarships. An additional portion of profit goes to the replacement trailer fund when possible.

If we are awarded any funding, we will apply the full amount to the concession trailer fund and hopefully raise the remaining funds by the end of December 2022 to make the replacement concession trailer purchase.

1. Please describe the problem or need which your project seeks to address.

The primary problem we need to address is replacing our concession sales trailer. The primary focus of the Danville Area Lions Club is addressing vision health for the underserved residents of Boone County thru vision exams and prescriptions glasses. We also maintain benevolence funding for victims of fires, floods, etc. as well as providing annual scholarships and community organization support thru donations and volunteer work. We do all of this with the profits generated by our concession sales. Our current concession trailer needs replaced. Without a replacement trailer we cannot continue to provide the same level of services and benevolence donations to Boone County residents. We are a nonprofit 501(C) 4 organization made up of volunteers. Our current concession trailer is nearing the end of its useful life. We must secure funding to replace it to continue serving the needs of Boone County residents.

2. Please describe goals and expected outcomes of your proposal.

Our goal is to secure funding to purchase a replacement concession trailer so that we can continue to provide vision health, scholarships, and benevolence to Boone County residents. Up to this point we have been self-funding and self-supporting. If we can purchase a replacement concession trailer, we will once again be able to provide services while being self-funded. A new concession trailer will allow us to continue to fund raise and continue to provide vision health, glasses, scholarships and benevolence help to Boone County youth and residents in need.

Our timeline is to purchase a new concession trailer by December 31st, 2022, so we can be ready and fully equipped to begin the 2023 year fully stocked and able to fund our missions thru concession sales.

6. Please describe your plan for sustainability of the project or initiative after thegrant award has been exhausted.

Our current concession trailer needs repairs that exceed the value of the trailer. It has water damage and electrical issues. In addition to age and normal wear and tear, the trailer has had additional issue due to water leaks. To increase the service life of the new trailer we will be buying a carport to park the unit under. This will shield it from the elements and extend the useful life of the trailer. The current trailer lasted 22 years. With the extra precautions and advances in building material the new replacement trailer should last 30 plus years with normal use. This will allow us to use our profits to serve several generations of Boone County residents with vision health/glasses, scholarships, and donations/benevolence help.

The Danville Area Lions Club mission statement is "to empower volunteers to serve their community, meet humanitarian needs, encourage peace, and to promote international

understanding through Lions Clubs". The Motto of the Danville Area Lions Club is "WE SERVE". We serve those who experience tragedy by having a benevolence fund to provide temporary aid and comfort to those displaced by disaster. We serve the youth of Boone County by providing scholarships, donations to youth sports and theater arts groups. Finally, we serve those residents who need vision health care by providing eye exams, glasses, and medical care to those without vision insurance or those who need vision are not covered by Medicare. Again, our motto is "WE SERVE", and we will continue to serve thru our fund-raising concessions.

The Danville Area Lions Club was chartered in 1990. We have served the residents of Boone County for 32 years. Our current programs include the gift of sight thru our vision health mission, awarding two scholarships per year to area high school seniors, and supporting community organizations and youth leagues with financial donations and volunteering opportunities.

The Covid 19 Pandemic caused the cancellation of fairs and festivals. A large source of revenue for our organization was concession sales at events such as the Boone County Fair, WV Coal Festival, etc. With the Covid lockdowns and cancellations we were not able to have concession sales. We continued to provide vision health and prescription glasses during this time and benevolence donations. However, with limited income opportunities and outgoing payments we find ourselves asking for grant money to help purchase the replacement concession trailer so we may continue our service to the community.
